A. If you own the property in which you reside please attach three (3) of the following:

1. Los Angeles County Tax Bill in your name showing residence property address.
2. A confirmed copy of an appropriate, filed tax exemption claim form stating the residence for which a property tax homeowner is claimed.
3. A Southern California Edison bill in your name showing residence property address.
4. A canceled check in your name showing residence property address.
5. Proof of Residency from the Los Angeles County Registrar of Voters.
6. Current DMV vehicle registration showing residency property address.
7. One other bill mailed to you at your residence address.
- 8) Completed Escrow papers.

B. If you rent the property in which you reside please attach three (3) of the following:

8. Copy of the lease/rental agreement.
9. A Southern California Edison bill in your name showing residence property address or, if such service is included as part of the rental agreement, you must provide satisfactory evidence that it is so included.
10. A canceled check in your name showing residence property address.
11. Proof of Residency from the Los Angeles County Registrar of Voters.
12. Current DMV vehicle registration showing residency property address.
13. One other bill mailed to you at your residence address.

I. If you and your child(ren) are sharing a home with another person:

14. The primary resident or owner must complete the **Primary Resident or Owner Form**.
15. Must attach three (3) of the documents as indicated in Section A or B.
