POLICY AND REGULATIONS FOR INTERDISTRICT PERMITS**

East Whittier City School District has adopted policies and regulations to govern the granting of Interdistrict attendance requests.

A Notification of Return form must be submitted each year by June 1st after the initial permit acceptance in order to maintain your child's permit status.

Students shall enroll in schools serving the attendance area of parent residence unless an Interdistrict attendance permit is properly completed and approved. A separate application must be made for each student.

- Students who are eligible for Special Education Services may be asked to obtain an Inter-SELPA Permit for individuals with exceptional needs, in addition to the Interdistrict Permit.
- No financial obligation shall be incurred by the district of residence for services rendered under this agreement.
- The parent/guardian is responsible for providing transportation to and from school.
- A permit may be denied or revoked at any time for the following reasons:
 - Continuance would lead to program or enrollment overload.
 - Student is excessively tardy or absent from school, or student is brought to school excessively early or left excessively late.
 - Student fails to uphold appropriate behavior standards.
 - Student fails to make appropriate academic efforts.
 - False or misleading information was provided.
 - Reason for the original issuance of the permit by the district of residence is no longer valid.
 - Other conditions that occur that would render continuance inadvisable.
- A permit may be denied if a permit for this student was previously revoked from another school in the East Whittier City School District.
- Failure to adhere to the above terms and conditions may result in the revocation of this permit. (E.C. 46600)
- A Notification of Return form must be submitted each year by May 31st after the initial permit acceptance in order to maintain your child's permit status.

A parent who is dissatisfied with a decision of denial of request for an Interdistrict Permit may appeal to the County Board of Education within 30 calendar days of the decision.
